[Effective for all new and continuing families from July 1, 2015 through June 30, 2016]

YOUNGER TODDLERS (13-24 months)	Year Round Monday - Friday 6:30 AM to 6:00 PM	\$370 OR - CCIS subsidy accepted - sliding scale fee by family size and income <i>12 school closings, parents charged</i>
	Year Round 3 days - say which days you need care on your application, or indicate that you can be flexible 6:30 AM to 6:00 PM	\$250 (private pay only - no special funding eligibility for this program category) <i>12 school closings, parents not charged</i>
	Year Round 2 days - say which days you need care on your application, or indicate that you can be flexible 6:30 AM to 6:00 PM	\$188 (private pay only - no special funding eligibility for this program category) <i>12 school closings, parents not charged</i>
OLDER TODDLERS (25 months-until 9/1 following 3rd birthday)	Year Round Monday - Friday 6:30 AM to 6:00 PM	\$349 OR - CCIS subsidy accepted - sliding scale fee by family size and income <i>12 school closings, parents charged</i>
	Year Round 3 days - say which days you need care on your application, or indicate that you can be flexible 6:30 AM to 6:00 PM	\$238 (private pay only - no special funding eligibility for this program category) <i>12 school closings, parents not charged</i>
	Year Round 2 days - say which days you need care on your application, or indicate that you can be flexible 6:30 AM to 6:00 PM	\$173 (private pay only - no special funding eligibility for this program category) <i>12 school closings, parents not charged</i>
PRESCHOOLERS (from 9/1 following 3rd birthday - 5 years)	Year Round Monday - Friday 6:30 AM to 6:00 PM	\$280 OR - CCIS subsidy accepted - sliding scale fee by family size and income <i>12 school closings, parents charged</i>
	These classes run from September to June only. Monday - Friday 6:30 AM to 3:30 PM	\$230 OR - Free to Head Start and Pre-K Counts eligible families. Complete application and submit with income documentation in order to determine eligibility. <i>Closed all days the Philadelphia Public Schools are closed, noon dismissals when the Public Schools close early, all paid except for winter and spring holiday weeks</i>
	This class is year round; \$168 rate Sep to June and \$280 in the summer OR CCIS co-pay year round Monday - Friday 6:30 AM to 6:00 PM	\$168 for Pre-K Counts eligible families. Complete application and submit with income documentation in order to determine eligibility. (Summer rate is \$280 weekly.) OR - CCIS subsidy accepted - sliding scale fee by family size and income <i>12 school closings, parents charged</i>

SCHOOL- AGERS (K – 6 th grade)	This is the school year rate.	Monday - Friday When elementary school is in operation, from school closing time until 6:00 PM , when elementary school is closed and CV is open, 6:30 AM to 6:00 PM	\$179 OR - CCIS subsidy accepted - sliding scale fee by family size and income <i>6 school closings, parents charged</i>
	This is the summer rate.	Monday - Friday 6:30 AM to 6:00 PM	\$235 OR - CCIS subsidy accepted - sliding scale fee by family size and income <i>5 school closings, parents charged</i>

NUTRITION PROGRAM

- \$40/weekly or \$8/day** for breakfast, lunch and snack everyday (free and reduced-price meals [\$4.25] for those eligible for the Child Care Food Program, Head Start participants are categorically eligible for free meals, and Pre-K Counts participants pay no meal fee September through June)

TO APPLY

- complete the application (your child may be younger than 13 months to get on the waiting list)

TO ENROLL

- toddlers must be at least 13 months old
- preschoolers must be at least 3 years old by September 1st
- the immunization record is required (doctor-completed health form documenting last physical exam may be submitted at the intake interview or within two weeks of enrollment)
- an intake interview is held with parent/guardian and child
- one week's fee in escrow is paid in cash at the intake interview, or two week's fee is paid for advance registration

OTHER FEE INFORMATION

- One week's fee in escrow, payable at intake, is refundable only if your child enrolls for at least three months and proper notice* is given before withdrawal.
- For advance registration, two weeks' fee is due in order to reserve the opening. Once payment is received, the enrollment date and intake interview is confirmed. This payment in the amount of two weeks represents the escrow deposit and first week's fee. If the intake and/or start date are subsequently cancelled or postponed, this deposit (of two weeks' fee) is forfeited and will not be applied to charges for a later intake and/or enrollment. The two-week deposit for advance registration is required for enrollments scheduled greater than two weeks' in advance (which includes the advance scheduling for most fall enrollments).
- Child care and meal fees are due weekly each Monday. Fees are due even if you or your child is out sick or on vacation.
- Charges for field trips are billed to families three weeks prior to the scheduled trip. [Head Start and Pre-K Counts participants are not charged a trip fee.]
- A nominal fee for student accident insurance is due every year in April.
- Families may be charged for up to ten emergency closings annually, in the event of building emergencies or school closures when public transportation is significantly effected.
- *A full four weeks' notice is required for withdrawals in June, July, August and September. A full three weeks' notice is required for withdrawals from October through May.
